## PARTICIPANT & VOLUNTEER'S AGREEMENT AND RELEASE FOR LIABILITY

- 1.) Voluntary Participation: I/We acknowledge that I/We have voluntarily agreed to participate in the Bighorn Outback Explorers sponsored ***Bighorn Outback Explorers Poker Run held on April 26, 2025, in Beatty, Nevada*** and all activities, events or programs. I/We understand as a participant and/or volunteer that I/We will not be paid for my services, that I/We will not be covered by any medical or insurance coverage provided by the Bighorn Outback Explorers, and that I/We will not be eligible for any Workers Compensation benefits; and,

I/We understand that I/We should take all precautions, use of safety gear and proper use of equipment to avoid or reduce this risk, but understand that this risk does exist; and,
- 3.) I/We knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releasees or others, and I/We assume full responsibility for my participation; and,
- 4.) I/We willingly agree to comply with the customary terms and conditions for participation and safety. If however, I/We observe any unusual significant hazard during my presence or participation, I/We will remove myself from participation and bring such to the attention of the Bighorn Outback Explorers event-volunteers immediately; and,

I/We, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless Bighorn Outback Explorers, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used for the project, activity, event or program, to the fullest extent permitted by law.
